

Terms and Conditions
(Vivit Japan Package)

RESERVATION

For reservations and additional information, please contact Amnet during normal business hours. Reservation can be confirmed if space available. Application form must be submitted at the time of booking.

PAYMENT

Full payment must be made by due date advised Amnet. If payment in full is not received by due date, Amnet has right to cancel reservation. Amnet is not responsible for any penalties, fare increases or fees charged for reinstating an airline reservation or all other services due to non-payment.

FORMS OF PAYMENT

Payment must be made check or cash. Amnet only accepts responsibility for a customer's check if the customer's check is made payable to "Amnet". All returned checks are subject to a \$40 service fee.

CHANGES AND CANCELLATIONS

After reservation is made, the following change and cancellation charges, per person, are in effect (below time is based on Japanese time and within business hour, Monday thru Friday and Saturday, Sunday, Japanese national holidays or holidays are excluded).

*After payment in full is made and more than 22days prior to departure: 50%
