

Terms and Conditions

RESERVATION- For reservation and additional information, please contact Amnet near you during Amnet's office hour. Reservation can be confirmed if space is available. Application form is required at the time of booking.

PAYMENT- Non refundable deposit of \$250 per person is required at the time of booking. Full payment must be made by November 21, 2008 or the due date advised by Amnet which comes earlier. If payment in full is not received by November 21, 2008, Amnet has right to cancel the reservation. Amnet is not responsible for any penalties, fare increases or fees charged for reinstating an airline reservation or all other services due to non-payment.

FORMS OF PAYMENT- Payment may be made by check and cash. Amnet only accepts responsibility for a customer's check if the customer's check is made payable to "Amnet" All returned checks are subject to a \$40 service fee.

TRAVEL DOCUMENTS- Travel documents such as airlines ticket and itinerary will be issued after reservation is confirmed and payment in full is made. It is the responsibility of each customer to obtain a passport valid for at least six months and visas for countries to be visited. As the entry requirements are subject to change. Please contact your travel agent or local consulates/embassies on visa requirement.

CHANGES AND CANCELLATIONS- After reservation is made, the following change and cancellation charges, per person are in effect (below time is based on Japanese time and within business hour, Monday through Friday and Saturday, Sunday, Japanese national holidays or holidays are excluded);
